Before Hon'ble Chief Minister, Odisha – Prayer for discussion with
State Executives of OMSA

Sub: In the matter of granting DYNAMIC ASSURED CAREER PROGRESSION (DACP) in favor of Doctors of OMS Cadre of our state at Par with Central Govt. Health Service's Doctors.

Hon'ble Sir,

We have the honor to bring the aforesaid matter on the captioned subject for your kind appreciation in order to remove the discrepancy and bottle-neck with regard to grant of DACP for the Doctors of OMS cadre at par with central Govt.health Services.

Govt.of India have since been pleased to introduce the DACP for their Doctors from 2006 after introduction of 6th Pay commission in respect of employees of Govt.of India. As a matter of principle the Pay Commission regards whatsoever may be are always applicable to the state Govt.Employees.In the light of that, principle so adopted the DACP granted by Govt.of India to their doctors is applicable to the Doctors of OMS cadre of our state.

In the meantime Govt. of Odisha, has been pleased to introduce RACP after introduction of the 6th Pay commission, modifying subsequently the ACP provision in the concern pay commission for its employee, other than the Group-A, entry officers. This happens heartburning of we doctors of OMS cadre since we are financially sustaining loss as there is no superiority in comparison to other employees keeping in the view of over educational qualification and exposing to health hazards in the medical profession, as in case of doctors of Govt. of India.

This may not be out of place to mention here that, our Hon'ble chief minister has since been pleased to opine that, the doctors belongs to special category from 2008, but, we have not been extended financial benefit such as DACP, given to that of the Doctors of Govt. of India. So, far as our knowledge goes there will be no much financial implication for the State Govt.to grant the DACP to that of the OMS cadre Doctors. To increase our efficiency and more to benefits of our patients care, the doctors of OMS cadre always should be encouraged by granting such benefit to that of the benefits givens to Doctors of Govt.of India.

Instances are there soon after the completion of Medical studies from Our state, the Doctors are eager to join in other medical institution, other than the state Govt. for availing more financial benefits in comparison to the benefits granted by our state Govt. In order to prevent and check for outgoing doctors from state it is highly necessary for the state Govt.to take up the issue of DACP and other benefits granted in regards to Govt. of India. The same shall be extended to the OMS cadre Doctors. So that, there will be no discrepancy and doctors will be interested to join in the state Govt. of Health Services, as a result of the deficiency of doctors in our health system will be solved and the doctors will also work more efficiently to deliver proper health care to the people of our state.
