

Welfare measures. OMSA members have vowed "zero tolerance to corruption" and are against to the practice of "awarding Prized Post to Corrupt Members".

- 3- The Parity in the higher posts (Additional Director & above) with similar state Govt. officers has not been implemented. It should be done immediately and around 360 posts in payband-4 should be created for oms cadre doctors.
- 4- In a Democratic Country and according to the Constitution of India 19(1)c, OMSA organized a protest' Mass Rasignation" on 18-04-2010 to settle the above mentioned issues. The authorities took punitive measures against members like one day stoppage of salary, departmental proceeding to break democratic movement. Despite Hon'ble Chief Minister's appeal to withdraw movement, which OMSA heeded to, the members were punished. OMSA resolved to withdraw all such punitive measures against the members to create trust and a congenial atmosphere to work.
